A Viet Nam Veteran's Wife Goes to Omaha

I am Carole Mersinger, wife of **John Mersinger**, Viet Nam Veteran, C2-22,4th/25th Inf. We live in Foley, MN and had a very nice trip to Omaha in October 2006, for the 22nd Infantry Regiment Society Reunion.

The following is my reminiscence of that trip that I had emailed to friends and relatives. We did get back --- and we did have a good trip, thank you... We left Foley on Thursday (Oct.5) in the early morning - 6:30 - Got to Omaha --- I think it was about 4:30pm. It was a long road. We almost got lost for a moment trying to find the Hotel, must of been the road construction. We were just tired, not confused - HA. A few circles around the block and we found it. The reunion was at the Omaha Marriott hotel and we stayed there also. We got in on the group rate so we were not the big spenders we

would like you to think!! Pretty nice place. A lot nicer than I'm used to that is for sure. I almost missed the usual cat hair on every thing. So we drove almost all day, all that peddling made us tired. We checked into our room. Room was good. A rest would of been nice but John was anxious to see the GUYS who are here. What a joyful reunion it was. they are truly Brothers.

I recall stories that my family would tell about in the "old days", several kids would sleep in one bed and often crossways so more would fit -- I always had a bed to myself growing up so don't know how cozy that could be. It sure would be close!! In Viet Nam, 6 guys, a squad, would share one personnel carrier (I would rather call it a tank) It was their home, it was the bed they shared. It was very close. Those 6 guys were even closer than brothers sharing a bed. They shared 24 hours a day with each other for about 12 months. They know each other very well.

They took care of each other, watched out for each other, they were partners in staying alive. Few blood brothers have that kind of bond with each other. These guys and the relationship they have with each other is unique.

John's squad was 6 very good men. It appears that they all worked at having a good relationship. About 4 years ago one of them died and so now there are 5 good men. One of them had not been seen since Nam, he came to Omaha and the 5 of them were together for the first time. It was very special.

A Platoon/Company is made up of several personnel carriers that travel and work together, they are a team. They looked out for each other also and were partners in staying alive. They broke bread together in a real sense as meals were dropped to them by helicopter. Many guys were at the reunion from the Platoon/Company that John was in - These guys were like family and know each other well. It is like brother sleeping in other beds in the same house.

The reunion was for the "22nd Infantry Regiment Society". That means that there were guys and gals there from WW II and

also from the current war but most of them seem to be from the Viet Nam times.

So now, what do these guys do for days?? Well, they talked and then talked some more! By the last night, the wives were amazed that they were STILL TALKING ! They just didn't seem to run out of stories. Yes, they shared stories, shared histories, reminiscing of the time when they shared that "bed" and that "house". There was much laughter with many funny stories that were shared and then someone would say "I remember that time too". Then there were somber stories with tears at other times with the realization that they are lucky to be here at all.

When I told people that I was going with John to an army reunion, I know there were some wondering thoughts - why would I even want to go???? Well first off - I have never been to Omaha before and what better way than with my favorite travel partner? I visited with other wives, did some walking, shopping, and some reading in-between. I do enjoy listening to the guys story telling. The excitement, drama, and emotion of the story teller and the listeners around the table. It is better than any show you could watch, I think. These were real people and real stories. They were there.

It all ended with a very emotional memorial service on Sunday morning. After that it was time to say good bye with hugs and tears. No one wanted to leave. Breaking up is hard to do.

Time for me to go to bed, folks. Never again will I wish I had a bigger bed!!

Thomas Bernardy KIA 1-2-1968

Several years ago I posted some comments on a WEB site that listed the names of all those killed in Vietnam. It was an Internet version of the Vietnam Wall. I posted comments under the section for **Tom Bernardy** who was a medic assigned to C 2/22.

Tom was a friend of mine. He was killed on January 2, 1967 at FSB Burt. Although I was also at Burt, I did not witness Tom's actions during the battle!

I have recently received an email from Teresa Bernardy who is Tom's niece. She has indicated she was born after Tom's death and her father is Tom's brother. She has asked me to forward her name and email to anyone who knew Tom and was willing to comment on what he was like. Please take the time to email Teresa. In response to my offer to give her contact information to others she said, "It would be amazing if I could hear from other people who knew my Uncle. I never got to know him because he died before I was born and it would help me get to know him a little. I will tell my parents about the meetings (reunions). Thank you very much for responding, it means a lot."

I have already planted the seeds of inviting her and her family to our next reunion in Washington DC.

The following is an excerpt from my email; to Teresa and it gives those of you not familiar with **Tom Bernardy** an idea of just what a distinct individual he was. He was the most mature and level headed nineteen year old I have ever met in my entire life. Never a day goes by that I do not think of him and can not help but wonder what he would developed into as an older mature man.

“Hello Teresa,

My name is **David Milewski** and I am the one who placed a message on the Vietnam Memorial Wall on the Internet. I am very pleased and proud to meet you. I served with your Uncle Tom Bernardy in Vietnam until his death on January 2, 1968 during the battle of Fire Support Base Burt.

I first met your Uncle when I was assigned to the third platoon of "C" company, 2nd Battalion, 22nd Infantry Regiment around the end of September 1967. Tom was a medic and there was one medic assigned to each platoon of men in the Company. Although Tom was only nineteen years old he was clearly more mature than most of the other soldiers. It was Tom's job to come to the aide of any of the men injured. He did that on numerous occasions including coming to my aide in November 1967. I was riding in an armored personnel carrier behind the machine gun when the vehicle ran over a mine buried in the road. Only the driver and myself were in the vehicle at the time as the other soldiers were walking as security on both sides of the vehicle. Tom would have been one of those men walking. When the mine exploded I was thrown from the vehicle to the ground and the first person to come to my aide was Tom! He was there only a few seconds after I hit the ground. That was Tom, he took his job seriously and was always instantly coming to the aide of his fellow soldiers without regards to any dangers to himself. I think that is why he was killed on January 2, 1968. We were engaged in the biggest battle

of the year with the enemy when he was killed. The enemy attacked us at night and many soldiers were killed and/ or wounded that night. Tom was one of them. Although I was at the battle, I had been transferred to another platoon and did not witness Tom's death. In fact, I did not even know he had been injured until several hours after the battle had stopped when some of my other friends told me about his death. There is no doubt in my mind that he died coming to the aide of his fellow soldiers as he was always where the action was going on!

I belong to two different organizations that meet every 18 months for a reunion. They also have newsletters and the members stay in contact with each other by email and/or telephone. One is the 22nd Infantry Regiment Society and the other is the Vietnam Triple Deuce. There are member of both organizations who knew Tom and would be honored to correspond with you! If you would like me to let them know to contact you I can do so! I will wait for your response. Our next reunion will be in the spring of 2008 and will be held in Washington D.C. You and any of your family members would be welcome to attend. We have had several family members of those Killed In Action attend our reunions which allowed them to sit down and talk face to face with their loved ones fellow soldiers! Please consider joining us as we would be honored!”

Do you think I can kill people and take over an airplane with an empty tube of toothpaste?" Poor lady, she didn't have Edd and Rich to calm her down, and I was only interested in how one can use a near empty tube of toothpaste as a weapon.

Where do I start with my highlights of the reunion? Getting together again with my Combat Brothers is, of course, the main event. Not just the Brothers that I served side by side with either, but also the many other Brothers of the society that have become so very important and dear to me in my life. One I will tell you about...

I would like to thank the Secretary of the Army for making **Jim May**, an official member of the 22nd Infantry Regiment. The Kool-Aid Kid went to his first anger management class at the VA Hospital in Portland, Oregon, Sept. 7th, 2006, and what a start it was. Whew baby! I ain't the only ticked off Veteran on this man's earth. Haha-haha!

No sooner did we get started with the class than a guy, a classmate, raised his hand to speak, as we were directed to do, and asked, "Could I see a raise of hands of those in attendance that are real Combat Infantrymen?" Six out of thirty or so, including myself, raised our hands. The man looked dumbfounded and then said, "I'd like to know what in the hell I am doing in the same class as those guys. We can't have the same problems. I was in Army Intelligence for crying out loud." The hair on the back of my neck rose immediately. An REMF was present.

He was answered that the causes of our anger problems may be different, but the treatment is the same.

The man immediately raised his hand again and said, "That's a bunch of bologna if I ever heard it. I am an attorney and I...yada, yada, yada." On and on he goes using his fancy attorney words and analogies (Note the first four letters of "analogies".) until he was interrupted by one of the Combat Veterans saying, "Will you shut the _ up? Or do I have to come over there and shut you the _ up?"

The attorney responds very quickly, nano-seconds, "Bring it on old man. Let's go outside right now and settle this _er!" ...so much for the fancy attorney words.

At this point, all Combat Vets, including the Kool-Aid Kid are on their feet getting ready for the big one. I shoved two empty desks in front of me and found myself holding a chalk board pointer thinking how much I could tick off the 250lb crazy attorney by hitting him with it. I sat it back down. Most in the room were pointing fingers and yelling at each other as they began to rise to their feet as well, but no where near as fast as we Combat Vets did. The teacher, or therapist-nurse-whatever called the cops who arrived in seconds. Two, large, fully armed Federal VA cops wanted us to sit down, settle down, be quiet, and to do those things, and I quote, "Right now gentlemen!"

I have to tell you. I loved it. It was exhilarating. I hadn't had that much adrenalin flowing through my little body in years. I felt alive even though I know perfectly well that I would not have come out of the potential brawl very well at all, but I would have recovered in my hospital bed with a smile on my face. But, once the cops arrived, apologies started to happen and people backed down. It's just as well—the right thing to do and all that. (The last sentence written in case my wife and therapist are reading.)

Guess who I rode down the elevator with? Yep, it was the crazy attorney. He said to me, "Hi there killer." I responded, "I hate _ing attorneys." We both then broke out laughing. I knew he meant no disrespect of Combat Infantrymen. And he knew that I could care less if he was an attorney or not. We did both agree that we should not be in the same class together at all—that the VA had made a mistake with this venture. We'll see.

Darn. The attorney got kicked out of the

class and now we are stuck with just boring clinical stuff and homework. As far as I can tell, my homework is to try and not get mad, and if I do get mad, to get over it quickly. My family and friends must have written that curriculum.

As I write this part, I have finished with the Anger Management Classes. I found one thing out for sure. Some of my anger I have no intension of ever letting go. I think that my fellow Combat Veterans understand what I mean by that. It helps me to 'never forget', and keeps me ready to defend the honor of our fallen Brothers who have suffered much disrespect, as those of us that survived have, from the dark-side personalities of our diverse society. Damn right I put them in their places when I hear those disrespectful comments about the very men that made it possible for those...uh...jerks to complain about anything their feeble minds come up with. Love it or leave it jerks! (Now, now K.A.K. Remember your anger management classes. Others may be jerks, but you do not have to be one.)

Hut ho heree ho...

Our local SW Washington NW Oregon 25th Infantry Division Vets group marched in the Veterans Day Parade in Vancouver Washington. Check us out at our new website at www.the25thdivisionveterans.com

The guys had ole K.A.K. count cadence while we marched. I laid it on them and the crowd loved it. I decided it was best not to sing the cadence about the girl from Kansas City, or the other...uh...racy ones we used to sing, but next year I will come up with something appropriate.
