REUNION LOAN REPAYMENT PROGRAM REVIEWED

The Board of Directors has created a Reunion Loan Program for the purpose of providing Financial Assistance to Members who wish to attend a reunion. Here's an outline of how the **Program** works:

Funds will be available for lodging, reunion registration, 22 IRS Reunion activities including tours and banquets. And incidental expenses. Incidentals include breakfast and lunch expenses.

No cash advances will be made. Vietnam Triple Deuce, Inc. will pay all approved items directly to the provider. This does not include incidental expenses. The Treasurer will be responsible for incidental cost.

No bar expenses or room service charges will be considered as **Program** expenses.

The Member taking the loan and the Treasurer will agree to loan repayment schedules. There are no timetables for repayment and there are no interest charges.

The Board will, 12 months before the next 22 IRS Reunion, determine the amount that is to be allocated for the **Program** and the number of Members allowed to participate.

Selection will be considered on a "first come, first served" basis.

The identity of the Member taking the loan will not be announced or in any way made public.

So, if you have been considering coming to a Reunion, but haven't because your budget won't allow for it, well here's your chance to come and visit with your Vietnam Triple Deuce Brothers. The funds we have in the Treasury are intended for this type of use and nothing would please your Combat Brothers more than to have you come to the Reunion. You earned the right to be at a reunion. Come and join us.

Anyone wishing to take advantage of the **Reunion Loan Program** should contact me. Remember, this is a "first come, first served" arrangement.

SPONSORED ATTENDEES PROGRAM

The Board of Directors has adopted a plan that will provide funds to support some of our needy Members in their efforts to attend reunions.

Consideration has been given to what we can afford to do, and to protecting the privacy of anyone who is ultimately selected by the Board to attend.

The program name is "Sponsored Attendees Program." The accompanying list will provide some of the highlights and conditions set forth by the Board.

The Sponsored Attendee, SA for the balance of this piece, must be an active Member of the Vietnam Triple Deuce and be sponsored by an active Member of the Vietnam Triple Deuce. The SA must be truly needy. Someone who just paid \$25,000 in college tuition or put an addition on their home may be temporarily broke, but that doesn't make them needy. Someone who has been struggling with PTSD and all the associated problems may be a better candidate. Someone who currently has an uncontrolled substance abuse problem to include drugs and/or alcohol would not be a good choice. The person sponsoring the SA will have to arrange for transportation to the reunion and be responsible for the incidental expenses incurred by the SA during the reunion. Incidental expenses would be such items as breakfast and lunch. Another might be transportation expenses on city busses. These incidental expenses will be reimbursed by the Treasurer at the close of the reunion. The sponsor must provide the Treasurer with the receipts and a check will be issued. The word of the Sponsor will be accepted whenever expenses are not readily documented with receipts. The Sponsor will be responsible for their own incidental expenses.

The Vietnam Triple Deuce will pay for all room and registration cost associated with the 22nd Infantry Regiment Society reunion. Rooms will be set up as double occupancy. We'll work out the Smoker, Non-Smoker issue as we go along. No charges for room services or movies or mini bar use or telephone calls will be paid for by the Vietnam Triple Deuce. Sponsors will have to make this understood by the SAs.

The Board will make every attempt to select SAs from as many of the Companies as possible.

This program will give us the opportunity to do for our Brothers what they would like to do for themselves, but are unable, because of circumstance, to do for themselves.

Those of you that have donated extra money when you pay your dues or bought Triple Deuce Merchandise have provided the seed funds that were necessary to bring this effort to reality. You can thank yourselves for your unselfish actions. To perpetuate the funding for this program, members and corporate sponsors will be encouraged to make additional donations earmarked specifically for this program. Those of you that will sponsor a needy Member will be able to take great satisfaction in bringing another Vietnam Triple Deucer back to where they belong, with the

men they lived and fought with. You will personify the motto, *"Deeds, Not Words"* and make all of us very proud of your unselfish efforts.

JAMES TOBIN DIES

James Anthony Tobin was born in Philadelphia, PA on Saturday the 17th of November, 1928 and died on Saturday the 17th of December, 2016 after a long battle with Alzheimer's disease.

He had an adventurous childhood playing ball at the "island", crushing pennies on the railroad tracks and hopping on moving trains to the next town and hitchhiking back. He then fell in love with music and played 1st trumpet for eight years, lettering in both High School and College. He received additional accolades for cross-country track and basketball.

Before graduating the seminary at Niagara University in 1957, he attended and played baseball at Glassboro Teaching College (now Rowan University) and worked in a Gold Mine in Lead, SD. While serving the Camden Archdiocese, he decided to also serve his country and joined the New Jersey Army National Guard in 1963.

Following in his father, Ralph's footsteps (an original "Devil Dog" with USMC at Belleau Wood in WWI), Jim answered the call of duty and volunteered for active duty in 1966, attended artillery school, and deployed to Vietnam in 1967. He was based at HQ in Dau Tieng, near the Michelin rubber plant in South Vietnam with the both the 4th and 25th Infantry Divisions. While serving the men in the field, (see attached photo of Christmas Eve mass painting by Jim Nelson and "Foxhole service at Operation Diamondhead, <https://www.25thida.org/TLN/tln2-48.htm>) he managed to reach back to the States and raise money to build a school for the local children and pay for their tuition (<https://www.25thida.org/TLN/tln2-33.htm>). For his efforts, the Government of South Vietnam awarded him the Armed Forces Honor Medal. After being promoted to Major, he requested to go to 82nd "All American" Airborne school and was stationed at Fort Bragg, NC. He then used his G.I. Bill to obtain His private, instrument and commercial pilot's licenses.

After making the difficult decision to leave the priesthood, he met Monica, a young, gorgeous, single mother and Vietnam widow who was teaching at the kindergarten on post and made her his wife in April 1970, he adopted her seven year old daughter, Patsy and they had their own daughter, Sarah two years later.

They spent the first fifteen years of their marriage in the Washington, D.C. area where he rose quickly through the ranks of civil service to become the Deputy Secretary of the Federal Trade Commission in 1976 and in his free time, he built a pool, grew a garden, mucked out horse stalls with his daughter Patsy, groomed the largest front yard in the neighborhood with his daughter, Sarah, as co-pilot on the riding lawnmower, and volunteered with the Civil Air Patrol as a spotter/observer pilot.

Wanting a change from the daily grind inside the beltway, he took a pay cut and moved the family to Denver, Colorado in 1985. There he ran the Mobile Emergency Response System team under FEMA that was responsible for maintaining continuity of government during a national crisis like a post-nuclear strike. His team provided communications and generators for the 1988 Yellowstone Fire, Hurricanes Andrew and Iniki, The Great Flood of 1993, Pope John Paul II's visit to Colorado for World Youth Day, and the Northridge Earthquake.

After retiring in 1995, he couldn't sit still and he began umpiring for community baseball leagues of all ages, flew around the country in his Piper Comanche (see photo), and volunteered as a rifleman with the All Veterans Honor Guard and participated in over 1700 funerals at Fort Logan Cemetery. After his daughter Sarah was commissioned into the USAF, Jim became actively involved with the 25th ID Association and served as the Vietnam Triple Deuce organization's chaplain for many years (<http://www.vietnamtripledeuce.org/newsletters/june05.pdf>).

In Charles Boyle's book, Absolution (<https://www.amazon.com/Absolution-Charlie-Company-Battalion-Infantry/dp/0991601440>), Father Tobin is quoted as saying, "Perhaps when this war is ended, we, the living will all join at some holy sepulcher of peace and talk with Andy and Jackie and Wally again. It is only then, after the many long years have dimmed your rage and softened your hearts, that you will come to know the true glory of their lives and the meaning of the deaths. They will be there waiting for us, these three, and all the others." I pray these boys, along with his best friend, COL Awb Norris; his sister, Rita and his niece, Eileen, will be there to greet this amazing man, hand him a bourbon, and keep him laughing until the rest of his family can be reunited with him.

Jim Tobin lived a life of service to his faith, his country, his community, his family, and his brothers in arms. In honor of the Triple Deuce and the way in which he led his life,

"DEEDS NOT WORDS" will be inscribed on his head stone.

The Archives' site allows you to request a family member's service records. You can use its web form or download and print the necessary documents. These are usually used to request veterans' benefits but are a fantastic way to memorialize a veteran in your family too. For example, did you know that the government provides free headstones for fallen service members?

Medals are a symbol of pride and honor in our military. Sadly, these can be lost or begin to show their age over time. The National Archives will happily send new medals to commemorate your loved one's service upon request.

For veterans themselves and next-of-kin, medals are issued for free. Medals can be requested [online](#) by Army and Air Force veterans. Navy, Marine Corps. and Coast Guard veterans may request theirs by mail to the Archives.

ADVOCATING FOR YOURSELF

One Man's Experience in the VA Healthcare System

As I mentioned before I thought I'd give a report about the hospital food at the Iowa City VA, but while I really don't have any complaints about it, I do have a tale to tell that may someday be of some help to you guys and gals. Several years ago a Cat scan showed a cyst on one of my kidneys that warranted keeping an eye on. It stayed just a bit larger than normal for six years or so, but earlier this year decided to grow real fast to baseball size, and removal was decided on. The first plan was to take the kidney it was growing on, and I requested that I talk to the department head about not removing the kidney if it could be saved. After a couple of long conversations, I finally got my audience with the boss and explained that I turn 70 this coming year, and from here on out I want both kidneys working to keep me off dialysis if possible. He readily agreed that it would be attempted, and I'm happy to report that while the danged thing was malignant, they did save all of the kidney, and I did not have to do chemo or radiation because it being a cyst rather than a tumor, they got it all.

Bottom line is that all the arrows are pointing up at my house, and that is good. But the fact that after doing a bunch of reading about the options, and asking permission to talk to the boss about those options, I was listened to with a positive result. We've all heard about getting a "second opinion" when faced with a medical crisis, and I'm sure some of you have done just that.

But I hope this tale shows that the first plan is not always the final plan if you politely, but firmly state your case backed up by some deep reading about the problem. If all of the VA hospitals were as good as the Iowa City one there would be no negative headlines about VA care. I can't speak for their satellites, but the main shed is top drawer...

ANNUAL FISHING INVOLVES BROTHERHOOD ACTIVITIES

Things were different this year. **David and Judy Milewski, C Co. 1967-1968 (David, NOT Judy!)** celebrated their 50th Wedding Anniversary in grand style. They made reservations for a week's long stay at a 16 room villa in Costa Rica, one with staff, three meals a day and an afternoon snack as well as a never closed bar. In attendance were **Uncle Kenny and Aunt Dianne Wilson, Uncle Dick and Aunt Karen Wilson**, daughter **Kim**, daughter **Deni**, her husband **Victor Meyerhoff** and their children **Alex and Zack**, Judy's sister **Carol Lee** and her son **Cassey Forster, Rick Milewski and Kris Baker**. Also in attendance were **Waine and Linda Richey**, David has known Waine since their days in the Cub Scouts. Waine is a **Marine Vietnam Vet** who served with the **9th Regiment, 1st Battalion, Delta Company**. As you can see the

Marines, as with all things they do, identify the unit they served with in a backwards manner. This was certainly a family affair and Waine, Linda, Gail and I were more than pleased to be included in this event.

I'll get to the fishing in a minute. Besides sitting around the swimming pool, eating too much and drinking too much we went on a sight-seeing cruise where we observed two types of monkeys, a number of lizards and more crocodiles than one would imagine. During this trip we ate in a restaurant in a remote village where the food was of a local flavor and quite good. We encountered a troop of Howler monkeys on the ride away from the river so we stopped to have a better look. David's nephew, Casey, decided he needed to get closer to the troop of monkeys in order to get better photos. Casey's advance was misunderstood by the dominate male in the group. The boss monkey wasn't going to let Casey, a good looking young man, anywhere near his troop and let out a warning howl that could be heard a quarter mile away. This set Casey to flight that ended only when Casey was back in the tour bus. I believe that Casey bought some post cards of the Howler monkeys in lieu of attempting to take any photos. There was horseback riding and a low level zip line that traveled to a number of platforms where the flora and fauna could be observed and the high level zip line. This zip line is divided into four segments, the first is a short trip, designed to familiarize one with how things work. The next two segments are longer in length with views of the surrounding jungles and mountains. The last segment is known as The Superman, so named because one lies face down on a canvas matt as opposed to sitting up as is done on the three other segments. The Superman is 4 clicks in length. That's a bit longer than the length, North to South, of Dau Tieng. The rider is lashed to the canvas and hooked up to the cable on rollers fore and aft and sent off from a height of 4,200 feet. The view is spectacular! There is jungle below, many villas to the left on a down slope with the Pacific Ocean beyond that. There isn't enough time to take in details at 65 mph. Yes, I'd go again.

The highlight of the trip was the Exchange of Vows ceremony. We all put our swimming suits away for the evening, put on our finest tropical wear and listened as David and Judy promised to continue to love and respect one another for another 50 years. Costa Rica has some 'requirements' that both Bride and Groom must agree to as part of the 'marriage contract.' In fact, the Judge who officiated at the ceremony made it very plain to all present that any violations of the vows would result in prison sentences for the violator. We were all sworn to report to the Costa Rican authorities any transgressions made by either David or Judy of the Costa Rican marriage laws.

Now, on to the fishing. As you can imagine, the Team Milewski fishing, eating and drinking crew were not about to leave an ocean side resort without wetting lines. So, we arranged a day trip on the Dona Del Mar with Captain

Fausto and Mate Jose. On board were Kim, David, Waine, myself and Uncle Kenny. Uncle Kenny, who had just celebrated his 80th Birthday, was there as an advisor. He retired from fishing a few years ago but as wanted to be certain all of us remembered what he'd taught us about catching fish and drinking beer. We started off by catching a few Bonita, which Jose put aside to use as bait once we located the game fish. The first note worthy catch was a Rainbow Runner caught by Waine. This fish, that none of us were familiar with, is identical in shape to a Yellow Tail and is considered a fine eating fish. The next noteworthy fish, a Wahoo, was caught by David. Then the fishing got hectic! I caught an 80 lb. Amberjack, Kim caught a Dorado and between break-offs, many Bonita and farmed fish all four of us managed to catch Sailfish, all in the 125 lb. class. It was now mid afternoon, we'd consumed all the beer that the crew had brought on board for us. Apparently, they had not heard about our ability to catch fish and drink beer at the same time, but Kim had brought a canvas bag full of beer with her and when she announced, "This is the last beer," a vote was quickly taken and we headed for the bar at the villa. The vote was unanimous. We also agreed that we'd had the best single day of fishing we'd ever had. We gave most of the fish to the boat crew but did bring the Wahoo and Dorado back to the villa where it was consumed along with the other dishes that the staff had prepared. In the morning I learned that many had 'issues' during the night and assumed that the fish might have been spoiled. I had no such 'issue,' and later learned, from a retired Merchant Sailor, that the 'issue' was too much protein for the digestive system. Anyway, should anyone reading this encounter a similar 'issue' while on a fishing trip I can tell you the cure is beer. Just keep drinking beer until you feel better. I think that Team Milewski may visit Costa Rica again, assuming that David isn't wanted for violating any of the aforementioned 'marriage contract rules.'

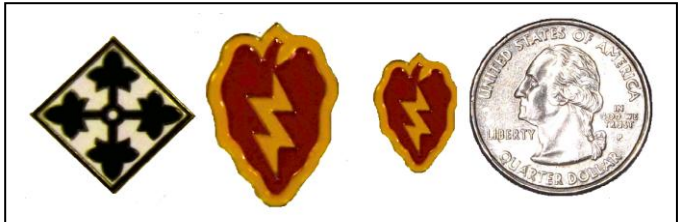
