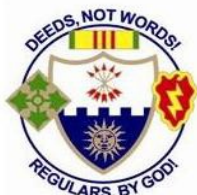

## REUNION ISSUES TO BE DISCUSSED

The upcoming reunion means it's election time for Vietnam Triple Deuce Board Members. Nominations and seconds may be made on the VN 222 Group e-mail or by submitting the nominations and seconds directly to Dean Springer, secretary [desprin@hotmail.com](mailto:desprin@hotmail.com) or 218-244-2326. Ballot preparation will be much easier if Dean has the names of all the nominees as soon as possible.

As a reminder, there are five Board positions. The elected Board Members are the only Officers who vote on VN 222 issues. Their first order of business is to elect a President, Vice President, Treasurer and Secretary. The Board also appoints other officers, such as the Chief Locator, Web Master, Newsletter Editor and Quartermaster.

Election to the Board and acceptance of an appointment as an Officer require that the individual have the desire and the time that is necessary to devote to VN 222 activities. There is much to do and much that needs to be done.

## SPONSORED ATTENDEES PROGRAM

The Board of Directors has adopted a plan that will provide funds to support some of our needy Members in their efforts to attend reunions. Consideration has been given to what we can afford to do, and to protecting the privacy of anyone who is ultimately selected by the Board to attend.

The program name is "Sponsored Attendees Program." The accompanying list will provide some of the highlights and conditions set forth by the Board.

The Sponsored Attendee, SA for the balance of this piece, must be an active member of the Vietnam Triple Deuce and be sponsored by an active Member of the Vietnam Triple

Deuce. The SA must be truly needy. Someone who just paid \$25,000 in college tuition or put an addition on their home may be temporarily broke, but that doesn't make them needy. Someone who has been struggling with PTSD and all the associated problems may be a better candidate. Someone who currently has an uncontrolled substance abuse problem to include drugs and/or alcohol would not be a good choice. The person sponsoring the SA will have to arrange for transportation to the reunion and be responsible for the incidental expenses incurred by the SA during the reunion. Incidental expenses would be such items as breakfast and lunch. Another might be transportation expenses on city busses. These incidental expenses will be reimbursed by the

Treasurer at the close of the reunion. The sponsor must provide the Treasurer with the receipts and a check will be issued. A sworn affidavit will be accepted whenever expenses are not readily documented with receipts. The Sponsor will be responsible for their own incidental expenses.

The Vietnam Triple Deuce will pay for all room and registration cost associated with the 22nd Infantry Regiment Society reunion. Rooms will be set up as double occupancy. We'll work out the Smoker, Non-Smoker issue as we go along. No charges for room services or movies or mini bar use or telephone calls will be paid for by the Vietnam Triple Deuce. Sponsors will have to make this understood by the SA's.

The Board will make every attempt to select SA's from as many of the Companies as possible.

The Board has decided that funds are available for 4 Sponsored Attendees at the 2009 Seattle Reunion.

This program will give us the opportunity to do for our Brothers what they would like to do for themselves, but are unable, because of circumstance, to do for themselves.

Those of you who have donated extra money

when you pay your dues or bought Triple Deuce Merchandise have provided the seed funds that were necessary to bring this effort to reality. You can thank yourselves for your unselfish actions. To perpetuate the funding for this program, members and corporate sponsors will be encouraged to make additional donations earmarked specifically for this program. Those of you that will sponsor a needy Member will be able to take great satisfaction in bringing another Vietnam Triple Deucer back to where they belong, with the men they lived and fought with. You will personify the motto, *"Deeds, Not Words"* and make all of us very proud of your unselfish efforts.

## MONUMENT UNDER ATTACK

Dawn Esposito sent a copy of the February 2012 Columbia magazine that contains an article about how a monument erected to honor the 10<sup>th</sup> Mountain Division World War II soldiers near Kalispell, Montana that was erected in 1954 after being granted a permit by the US Forest Service. The site was chosen because it is a frequently visited ski area and the statue was chosen because it was similar to the statues that were seen all across European ski areas.

Apparently, the permit must be renewed every ten years and the Wisconsin-based Freedom from Religion Foundation has challenged the issuance of the permit because part of the monument is a statue of Jesus. The argument for keeping the monument in place is that it is no different than the religious symbols that appear on Civil War memorial sites as well as those that appear in Veterans cemeteries all across the Nation. Additionally, people do not go there to pray, as they would in a church, but to ski. The argument for removal is that the statue forces a religion on the public. The sentiment in the area

is that there has never been a complaint about the memorial and that they would like it if people from away didn't come to the area to tell them how to live.

SUBJECT: Woman of the Mountain Nomination for Mrs. Dawn Esposito

1. I strongly recommend Mrs. Dawn Esposito to be the 2012 winner of the Man/Woman of the Mountain competition. I have known her since 2006 and know of no person who has given as much back selflessly to the Soldiers and Families of 2<sup>nd</sup> Battalion 22<sup>nd</sup> Infantry Regiment, the 1<sup>st</sup> Brigade Combat Team and to a smaller extent the 10<sup>th</sup> Mountain Division community.

2. Mrs. Esposito's son Michael served in A Co, 2-22 IN and tragically lost his life on March 18, 2004 in Miam Do, Afghanistan. This tragic event was the beginning of Dawn's relationship with the 10<sup>th</sup> Mountain Division. After the death of her son, she kept in contact with Triple Deuce while still deployed in Afghanistan. As the unit redeployed a couple months later, she traveled to Fort Drum and welcomed home all the Soldiers of the Triple Deuce, especially those that knew her son. Her support has continued to grow stronger over the years, despite the changing of names and faces in the Division. A summary of her contributions follow:

May 2004 – As 1BCT returned from Afghanistan, Mrs. Esposito, helped prepare welcome home packets for all returning Soldiers in Triple Deuce.

Christmas 2005 – With Triple Deuce deployed, Mrs. Esposito took lead on setting up Christmas party for all Triple Deuce families at Fort Drum. Through her own connections she was able to provide a valuable Christmas present to every family member in attendance.

Summer 2006 – Mrs. Esposito purchased linen for every Single Soldier living in the Barracks. She delivered all the linen to Fort Drum and helped other

FRG volunteers set up each room in the barracks so returning Soldiers would feel welcomed as they returned from Iraq.

Christmas, 2007 – Mrs. Esposito again acquired valuable Christmas gifts from other donors and delivered them to Fort Drum for the Triple Deuce Family Christmas party while the Battalion was deployed to Iraq.

December, 2008 – Mrs. Esposito traveled to Fort Drum for the dedication of the Battalion's memorial to our fallen comrades. While traveling from Long Island, NY she was in a car accident, was hospitalized overnight, but still insisted on departing the hospital in New Jersey in the early morning hours to make the afternoon dedication. It took Mrs. Esposito over a year to recover from all her injuries, and to be able to work and drive again. Her stalwart will to be at the dedication ceremony, despite her fragile condition, was an inspiration to all Soldiers and Families.

Christmas, December 2009 – With the Battalion still at Fort Drum, but soon departing for Afghanistan, Mrs. Esposito planned an extravagant Christmas Party for Single Soldiers in Triple Deuce. She coordinated for a band, comedians and gifts for all Single Soldiers. She wanted to make sure each Soldier knew they were special and not forgotten. Additionally, she again supported the Triple Deuce Families thru the delivery of Christmas gifts that were distributed the children across the battalion.

Spring 2011 – When the 10<sup>th</sup> Mountain Division Staff lost LTCs Paul Bartz and Tom Belkofer in Afghanistan on a Leader's Recon, she had flowers delivered to the Division Headquarters on the day of the memorial ceremony and offered to help the families in any way.



Spring 2011 – Mrs. Esposito played a leading role in planning, and coordinating the 1BCT Gold Star Banquet honoring the families of their fallen comrades. She was asked to be a keynote speaker and in doing so, shared her perspective and heartfelt connection and concern to all of the Gold Star families present. Many of the Families engaged her as an inspirational resource. Her influence had grown well beyond Triple Deuce.

Summer 2011 - At the conclusion of the Annual Remembrance Ceremony, Mrs. Esposito met with BG Miller, and extended an invitation to assist the families of the 10<sup>th</sup> Mountain Division. Additionally, she presented a flag flown over the New York State Capital to BG Miller for all the soldiers of the 10<sup>th</sup> Mountain Division.

Fall, 2011 – Mrs. Esposito again planned a first class Single Soldier Event for the Soldiers of Triple Deuce. She led a potent group of volunteers providing all food, gifts and entertainment for the Soldiers. Additionally, Mrs. Esposito coordinated a trip to Disney World for a small group of soldiers from the unit, at no cost to them. This is a small example of her incredible dedication and care to the soldiers' of this Division.

3. Mrs. Esposito has extended her good will to help the Soldiers and Families in 2BCT.

4. Mrs. Esposito travels to Fort Drum routinely for each year's Annual Remembrance Ceremony, for most Triple Deuce and 1BCT Changes of Command, welcome home and deployment ceremonies and Christmas Parties. She actively maintains contact with Soldiers and the chain of command across Triple Deuce.

5. Mrs. Esposito is an active member of the Gold Star Mother organization and informally reaches out to many 10<sup>th</sup> Mountain Division families and serves as a beacon for all our Division's

Gold Star families. She is also a tremendous ambassador of the Division and to the broader armed forces towards many southern New York organizations, businesses and political offices. She is a strong advocate of active duty service members, veterans and in particular, wounded warriors.

6. Dawn is not an affluent person, though she is rich in many other ways. She works as a nurse. I know of no one with a bigger, more compassionate heart than Dawn Esposito. She is an aggressive fund raiser. The vast amount of money she has provided in taking care of our Soldiers was largely through donations of other Patriots that she would network with for the betterment of our Soldiers and Families.

# BILL RABBIT DIES

A celebrated artist based in Pryor has died. Bill Rabbit, 65, died Monday

Rabbit was one of the most successful Native American artists in the world. He has received numerous awards and recognitions for his artwork, including the Oklahoma Heritage Award in 2001 and Master Artist at the Five Civilized Tribes Museum in 1986. He received Artist of the Year at the 1989 Indian Arts and Crafts Association wholesale market, where his poster, "Yesterday, Today, and Tomorrow," was selected as the official poster for the IACA and is the only poster in the history of the IACA to sell out.

Among his many awards, Rabbit was chosen twice by the Oklahoma State Arts Council to create an artistic Easter egg to be displayed on the White House lawn. After the Easter celebration, these eggs were sent to the Smithsonian, where they were put on permanent display. Internationally, visitors to the Vatican can admire Rabbit's work displayed alongside artists such as Rembrandt and Picasso.

Rabbit was self-taught in acrylic painting and jewelry making. He sharpened his skills through experimentation and did little preliminary sketching. Rabbit was influenced by other artists and tried to capture something of their spirits, skies, colors and forms.

During the Vietnam War, Rabbit served 18 months in the 25th Infantry Division alongside acclaimed filmmaker, Oliver Stone. Stone would later win an Academy Award for "Platoon," a portrayal of his tour of duty that he shared with Rabbit. Rabbit's service years during this time in history taught him that life's moments are precious. Becoming an artist only justified his path in life, and he turned those precious moments into something he loved.

## Obituary : William "Bill" Rabbit The Pryor Times Thu Apr 12, 2012,

William "Bill" Rabbit, 65, of Pryor, died April 9 in Tulsa. He was born in Casper, Wyo. to Swimmer Dave Rabbit and Doris M.E.H. (Dixon) Rabbit on Dec. 3, 1946.

He attended school in Casper, where he watched the color changing in the skies and the form of things in nature which influenced him. This was reflected by comments from his kindergarten teacher who recognized his talent and his unyielding spirit: "Bill draws and paints unusually well, and is original. He is helpful in the care of the room, however too often he is not cooperative in group activities and is quarrelsome with a few of the children."

Not only did his artistic potential begin to rise early on, but also his business savvy for Rabbit sold his first watercolor for \$4, in the fourth grade. Other than a class in

grade school that he had taken for two weeks, he had no formal training in art. Later Rabbit moved to Collinsville, where he stayed until he voluntarily enlisted in the Army, serving in Vietnam. He served for 18 months in the 25th Infantry Division alongside filmmaker Oliver Stone. He said that Vietnam taught him that life's moments are precious. During this time he met and married the love of his life, Karen Elaine Jones from Tahlequah, on March 25, 1969.. His self taught expertise and use of the paintbrush has allowed him to be the recipient of numerous awards and recognitions. A few of them include the following: Cherokee National Treasure, Five Civilized Tribes Master Artist, I.A.C.A. Artist of the Year, "Night of the First Americans" John F. Kennedy Center Washington, D.C., Cherokee Honor Societies Medal of Honor Award, and Top 10 Artists in America along with his beloved daughter Traci, Trail of the Painted Ponies. He was most proud of the Cherokee National Treasure award, and carried it close to his heart.

Rabbit was always concerned with the salvation of anyone that he met, and was always willing to share his love of Christ and his own salvation. Questioning others to make sure that they knew the Great Creator and where they would spend eternity. There are not enough beautiful words to illuminate the life of Bill Rabbit...but still said it best..."Life has been kind to me. I am thankful I've had the opportunity to see the things I've seen and do the things I've done. But if I died tomorrow I would feel so blessed and I hope God puts me in charge of painting rainbows." His most precious legacy that will carry on his great life is his grandchildren.

Rabbit is survived by his wife Karen Rabbit of Pryor; daughter and son-in-law, Traci Rabbit and Dwight Stone of Locust Grove, daughter and son-in-law, Kim and Wade Enyart of Colcord; son, Stephen Wesley Proctor of Chouteau, son and daughter-in-law, Billy and Miranda Rabbit of Pryor; eight grandchildren; many other relatives and friends. He was preceded by his parents, Swimmer and Doris Rabbit; two brothers, James and John Lee Rabbit; one sister, Wineva Goins.

A man who "was how you'd want people to be," died in an early morning fire Sunday in a remote area of so Lackawanna County.

Robert Hemphill, 69, of Covington Twp., a decorated retired Army infantry lieutenant colonel, community volun-

teer and author, was killed when his two-story home on Freytown Road burned to the ground.

He died from carbon monoxide poisoning due to smoke inhalation, according to Lackawanna County Coroner Tim Rowland.

Mr. Hemphill's wife Carol, was not home at the time of the blaze. She reportedly was on a humanitarian trip with the Rotary Club. Officials held off identifying Mr. Hemphill until his wife could be notified of his death.

Mr. Hemphill was deeply involved in the community through organizations from the Rotary and Masons to the VFW. He was slated to become Rotary District Governor in 2013 and was former commander of the John J. Michaels VFW Post 5207 in Daleville.

"He woke up every day with a sense of purpose," Kevin Duffy said. "He was a loyal friend and patriot - living the military code."

After meeting Mr. Hemphill through Rotary, Mr. Duffy, of Moscow, came to call him a friend. The two had dinner together at the Fox & Hound Inn on Saturday. "He was how you'd want people to be," Mr. Duffy said.

Retiring as a lieutenant colonel, Mr. Hemphill was awarded a Purple Heart from Vietnam combat wounds, a Silver Star for gallantry in action, and four Bronze Stars with Vs for valor in combat.

Donnie Hart, who is building a home next to the Hemphill home, considered his new neighbor, whom he had known for three years, a hero.

"He was a good man," Mr. Hart said. "I think he was a hero for what he gave to our country. He was a humble guy. He should be remembered and respected as a good American and a good community man."

Mr. Hemphill wrote "Platoon: Bravo Company," which portrayed his time as an Army captain in Vietnam. Film director Oliver Stone was under his command in Vietnam from Oct. 1, 1967, to Feb. 18, 1968. Mr. Stone later directed the movie "Platoon." Mr. Hemphill wrote "Platoon: Bravo" in reaction to Mr. Stone's film, taking exception to the film's portrayal of American troops. Mr. Hemphill said the troops in his platoons displayed bravery and heroism and were too busy being soldiers to get into the kind of trouble depicted in the film.

Friends and associates agree that for Mr. Hemphill, the sense of duty carried over to the community. When an older woman with no family was ill, Bob and Carol Hemphill made sure she was cared for in the hospital, took care

of her dog, and helped her get set up at home to convalesce, Mr. Duffy recalled.

"He recognized a duty to his country and duty to his fellow man," Mr. Duffy said. "He was larger than life, yet had no false bravado."

According to his author biography on Amazon.com, Mr. Hemphill grew up in Georgia and graduated from the University of Georgia with a Bachelor of Arts in political science in 1964 and a master's degree in international relations at Johns Hopkins University in 1973. A career military man, he served in the Army from 1964 to 1989, retiring as a infantry lieutenant colonel.

He would do anything, any time for a veteran, recalls Bill Lamond, John J. Michaels VFW 5207 Post Commander. Mr. Hemphill was always willing to help, to visit ailing vets, or to speak to school children or community groups about patriotism and the military.

"I looked up to him, we all looked up to him," Mr. Lamond said. "We are in shock."

The fire at the Hemphill home started in the dark of night in the isolated area, and may have burned for an hour or two before being reported by a PPL crew in the area, said Covington Fire Chief Brad Jones. By the time fire crews got there at about 6:30 a.m., the home was burned down into the basement foundation, Chief Jones said.

A business run by the Hemphills, The Woodlands Stable and Tack Inc., was a significant distance away from the blaze and neither animals nor property were harmed at the stable. but the Hemphills' dog, Harley, died in the blaze.

## A Triple Deucer Reminisces

I first met Bob Hemphill and his wife Carol at a 3rd of the 22nd reunion in Washington D.C. He was once a Capt. of B. Company. He was sporting a First National Flag of the South (Civil War Era) I learned he was working on a book titled "Platoon Bravo Company" which was a first hand account of his tour of duty 1967-68. Included were his memoirs of the night of January 1, 1969 (FSB Burt). This historical book is unique because it is a tunnel vision account. I could understand the interpretation because we all had that experience, that is to say it is a first person dialog.

He told Sharon and me that Oliver Stone was in his company as a Sp. 4. He disagreed with Stone's interpretation of the soldiers that he served with in the movie "Platoon". The purpose of Bob Hemphill's book was to express the respect he had for those he served with and the false image that had been portrayed. Bob asked me to do the painting that would be used for the book cover. I told him I needed a snapshot of him at that time in Vietnam to use for reference. He was truly a patriot and we consider it an honor to know him. We extend our condolences to Carol
