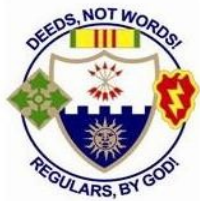

Hours of operation for reservations are Monday through Friday from 6:00 am to 11:00 pm (Pacific); Saturday and Sunday 7:00 am to 11:00 pm (Pacific).

Individual accounts will be created for each guest and they will be responsible for their own account. When you register, the equivalent of one (1) night's room and tax will be required in either the form of a credit card with expiration date, company/personal check (received by the hotel prior to 2 April 2017), American Express; Diners Club; MasterCard; Discover; VISA; JCB or Cashier's Check. POINT OF CONTACT FUNCTIONS IDENTIFIED

The Point of Contact, POC, are positions held by four Members from each Company. Members identify themselves with the time periods in which they were with Triple Deuce in Vietnam, these four periods are Boat Originals, 1967 Replacements, 68-69 Guys and the 1970 Cambodia Guys. A POC position has been created for each of these time frames for all the Companies. The POC positions were created for a number of

reasons. The primary reason was to better serve the Active Members by establishing open communications between Members. The question of, "How do I get the message out to my buddies," can now be handled by the POC that the Member identifies with. And, should the POC determine that the message should go beyond their particular group, the POC can pass the message along to the other POC's.*

Another reason for establishing the POC's was to encourage Inactive Members to re-join VN 222. There are nearly 400 Inactive Members, many of these Members joined with the hope of finding a Buddy. When they didn't find the Buddy, they dropped out. The Board believes that POC's can help bring these Inactive Members back by establishing contact with them for the purpose of helping them find who they are looking for. An example of how this might work is as follows: A POC contacts an Inactive Member who was in a different platoon than the POC, so they didn't know one another in Nam, however, the POC does know a Member, Active or Inactive, who was in the platoon in question. He gets these two in contact and makes some suggestions on how best to search for the missing Buddy. It may be as simple as looking through the Inactive Roster or it may be more involved, like going to a web based search engine to look for the missing Buddy.

There are other situations where the POC's will help, like planning a Mini-Reunion, or planning a Company Dinner evening at a 22nd Infantry Regiment Society Reunion.

The point is that POC's can only make Vietnam Triple Deuce a stronger organization by keeping channels of communication open between the particular group they serve, the other groups in their respective companies and the remainder of Vietnam Triple Deuce.

*The most efficient way for POC's to communicate with their respective group Members is to create a Contact Group in their e-mail program. In Microsoft Outlook this is done by opening the

Contact section and selecting the New Contact Group and then adding the e-mail address of all those from that group. Those without e-mail will need to be contacted by phone.

Note: You will see that many of the POC positions are open. If you would like to fill one of those positions, please contact Jim May, jlmay@tds.net

Note: Everyone with e-mail should be on the VN 222 Group e-mail. If you are not, then contact George Dahl, gtdahl@iphouse.com George is the moderator of the Group e-mail, he will provide you with instructions on how to get on the Group e-mail.

VETERAN ASSISTANCE PAGE SHARED

In the Fall 2015 editions of the 22nd Infantry Regiment Society and the Vietnam Triple Deuce Newsletters plans were announced to build a file of Veteran Service Offices, VSO's, who had a proven record of helping Vets in dealing with the Veterans Administration. The plan was to build a registry of these VSO's so that 22nd Vets would be able to contact them should they need to deal with the Veterans Administration.

To date, Pete Gaworecki has built and opened a page on the 22nd Web Site that has material that will be useful to any Vet who is thinking about contacting the Veterans Administration for assistance. What is now needed is information from those of you who are reading this. This information will be used to create a roster of proven VSO personnel.

If you are in the VA System and have used a VSO to help you in dealing with the VA the name of that VSO should be on the registry. All you

need to do is send the name, location and contact information of your VSO to Bill "Doc" Matz at docmatz222@comcast.net If you don't use a computer then call Doc with the information. His phone number is 615-837-9854. Please call after 1 PM.

This is an important project not only for Vietnam Vets but for the AFG-IRAQ who are in need of assistance in dealing with the VA.

VA BENEFITS – HOW THE VA RATES DISABILITIES

When a veteran applies for disability compensation benefits, the VA has to decide if the veteran is eligible and entitled to those benefits and how much they can receive. The VA's [initial decision](#) is called a Rating Decision, where the veteran is assigned a percentage for their service-connected disability that determines how much monthly compensation they will receive.

In order to determine how much compensation the veteran is entitled to, the veteran is assigned a rating. The rating is a percentage, ranging from 0% to 100% and increasing in increments of 10%. The VA rates mental and physical conditions based on the average decrease in earning capacity due to that condition. The VA rating system is meant to be a way to compensate veterans for a loss they suffered in service that decreases their ability to earn a living for them-

selves and their families. The higher the degree of disability, the greater the compensation because the more severe the condition, the greater the impact it has on the veteran's ability to earn a living.

The goal for most veterans is a [100% disability rating](#), also known as total disability rating. This rating entitles the veteran to the most amount of money (currently \$2,906.83 per month) because they are considered totally disabled. If the disability would make the average person incapable of work, a total rating is assigned, even if the veteran is working. The other way to get total disability rating, without reaching 100%, is through [individual unemployability](#).

On the other side of the spectrum, the VA can assign a 0% rating, or a noncompensable rating. 0% does not qualify the veteran for monthly compensation, but it does have its advantages. A noncompensable rating establishes service-connection, preserves the right to seek higher compensation if the condition gets worse, and entitles the veteran to other benefits such as preference in federal/state jobs. If the veteran has two or more separate noncompensable service-connected disabilities, the VA can grant a 10% disability rating.

The rating schedule lists all types of diseases and conditions that tend to result from military service. The ratings are categorized by body system, with

each system containing a series of diagnoses and each having its own numerical code. This numerical code is called a diagnostic code, which is then assigned a percentage, and each percentage has a designated compensation amount. For each degree of disability, there is a description of the symptoms the veteran must have in order to qualify for that evaluation. The degree of disability increases with the severity of the symptoms. The rating board will determine the severity of the symptoms and the appropriate rating for the veteran based on the evidence provided, such as service records, medical statements, buddy statements, and VA examinations. This is why it is so important to get the right evidence into the VA so they can make the right decision and assign the highest rating possible. The goal is to prove the highest level of severity in order to get the highest rating and receive the most compensation.

The VA is supposed to choose the diagnostic code with the highest evaluation under which the veteran qualifies, and avoid evaluating the same disability under different diagnostic codes. When there are two different evaluations to apply, the VA will assign the higher rating of the two if the disability meets the criteria for the higher rating (if not, the lower rating will be applied). Not all disabilities are listed in the rating schedule, so when the condition is not included, it will be rated under a closely related disease or injury. This is known as an analogous rating. The analogous

condition should affect similar functions in the same part of the body and have similar symptoms.

When there are two separate disabilities, the overall percentage is determined by combining the individual ratings, not adding them together. The VA does this by considering each disability in order of severity, beginning with the highest evaluation, and subtracting that from 100%. The number that remains is what the VA considers the remaining healthy part of the veteran, so the next disability is subtracted from that remaining number. The result is then rounded to the nearest tenth. For example, if there are two disabilities rated at 50%, the first 50% is subtracted from 100%. The second disability of 50% is taken from the remaining 50%, resulting in 75%, which is then rounded to 80%. There is also an app that can help you calculate combined ratings called VetCalc that can be downloaded in the App Store. If you do not agree with what the VA has decided and you think you are entitled to a higher rating, you can appeal your decision. Referred By

The Museum is well laid out and is filled with many interesting items with the center piece being the USS Nautilus, the first nuclear powered submarine. After about two minutes below decks on the boat it became apparent that Pete would not have done well on a submarine. Anyone taller/bigger than me would find moving through a submarine difficult. I have been on a WW II type sub and it was even a tighter fit than the Nautilus. That being said, I would encourage anyone who is in the New London area to visit the museum and the Nautilus.

Well, it was lunch time and Pete asked his navigation system to find a diner. I am happy to re-

port that the Navigation system, once again, took us on a tour of the entire Thames River Valley before bringing us back up near Mohegan Sun where we ate at a Five Guys Diner. Message for **Ruth Crocker**. Ruth, I'm sure that we rode past your house at least twice. We did every house between Groton and the Sub Base, both sides of the river.

Well we had lunch and went back to the hotel to prepare for the evening's event, dinner at the Michael Jordon's Steakhouse. Pete and I had decided we'd both wear our blue blazers with the 22nd Infantry Regiment Blazer Badges and our ORA's. We wanted to make a proper showing as representatives of the Old Goat's Squad. I don't know if the young Vets were confused or impressed with our attire, but it did give us the opportunity to explain what the 22nd Infantry Regiment is about and how the Vietnam Triple Deuce fits together with the Regiment Society.
